50,000 conversations and counting

"Who's Your Agent?"

With one simple question, hundreds of HCM Partners confidently engaged over 50,000 adults in planning conversations to complete a Health Care Proxy and Personal Directive using the <u>Getting Started Tool Kit</u>.

<u>Health Care Planning Ambassadors</u> started powerful health care planning conversations with adults & families where they live, work and gather, including at —

- Worcester Council on Aging, where 135 adults in 4 Multicultural Groups used a translated MA Health Care Proxy to make a plan;
- Harvard Pilgrim Health Care, where 5 Care Management Teams became Ambassadors to directly empower & inform their members;
- **UMass Memorial Health Care,** where Ambassador Graduate Nursing Students and Medical Students confidently open care planning conversations with patients;
- **Baystate Health's** Primary Physician Practices, where trained Ambassadors fold the "Who's Your Agent?" program into the daily patient flow;
- **Councils on Aging** across the Commonwealth, where Ambassadors are hosting "Pizza & Proxy" community events, to 'share a slice and complete your proxy'.

"Patient Portal Challenge"— the results are in!

We wondered- if you could, would you upload your Health Care Proxy & Personal Directive into your Patient Portal, to easily view, update, and share, and would you want these documents to be available in your medical record? Working with our partner, **MA Coalition for the Prevention of Medical Errors,** we surveyed 100 respondents. Survey results report 100 respondents would upload their Health Care Proxy and 94 respondents would upload both the HCP and Personal Directive, to better direct and communicate their health care decisions. New England Age-Dementia Friendly Initiative

Honoring Choices has convened the age-dementia friendly leaders in MA, NH, VT, RI, and CT, to ensure all adults who live at our borders and travel through New England will receive quality care that honors their values & choices. Early next year, HCM will post each state's planning documents, and coordinate our healthy aging initiatives to create a unified New England Age-Dementia Friendly Community.



Improving the Serious Illness - MOLST Process

Honoring Choices is working with many of our partners and the state to help build a MOLST process that is responsive to the changing health needs and choices of patients all throughout serious illness. Some of the 'works in progress' include:

- Guardianship MOLST Advisory Group, co-hosted by our partner **Massachusetts Health & Hospital Association**, to protect the rights of seriously ill incapacitated adults;
- Dept. of Public Health Expanded MOLST Subcommittee, of the Palliative Care & Quality of Life Advisory Council, is a multidisciplinary group working to help DPH improve the MA MOLST process. Ellen DiPaola, HCM President, serves as subcommittee chair;
- EMS & MOLST: 5 Things To Do Ahead of an Emergency. Free downloadable guide, developed in collaboration with MA EMS.
